Background

Back in August 2021 the Scottish Police Authority co-hosted an online Round Table discussion on the theme of *Policing and the Pandemic: the Scottish Experience*. You can watch a recording of this event on our LiveStream channel and additional materials are available on <u>our website</u>, including the Programme, Presentations and the post-event Newsletter.

It was agreed on conclusion of that Round Table event that there would be benefit and public interest in a follow-up event taking place approximately 12 months on, with more of a focus on the learning outcomes from policing the pandemic, the role of oversight activity during the pandemic, and the legacy of the pandemic on crime patterns and trends, and other policing demands.

This Event

This follow-up Round Table event will begin by featuring a number of brief, leader-led presentations from various organisations involved in policing the pandemic in Scotland, and the oversight of policing in the public interest. Professor Susan McVie will also present concluding findings from funded research the use of Fixed Penalty Notices by Police Scotland. The <u>Event</u> will then develop into a Round Table discussion. It is anticipated that the knowledge exchange outcomes and learning will be used to shape current and future policing strategy and policy.

The Event will be broadcast on <u>livestream</u> and a recording will be made available on the SPA website for those unable to watch live. The public and stakeholders/ partners will be encouraged to watch 'live' and submit comments/questions in a moderated chat facility, and the Scottish Police Authority will also use a variety of channels, in advance of the Event, to generate questions and areas of interest from the public and stakeholders, including via our <u>Citizen Space</u> portal.
