1.	Purpose									
2. 2.1 3.	This paper provides the Scottish Police Authority (SPA) with a weekly update on policing changes seen during Operation TALLA, Police Scotland's COVID-19 response. This report contains the preceding week's information and data on changing demands within the service centre, incident attendance and crime. It will also consider our COVID-19 response including our use of the emergency legislation and how we are assisting our officers and staff welfare throughout these challenging times. This update will have a reporting period, Thursday to Wednesday. For the purpose of this report, the week of Thursday 7 th May 2020 to Wednesday 13th May 2020 is considered. 4.	Alignment to Police Scotland Strategic Outcomes*									
4.1	This report aligns to both Police Scotland's Strategic Outcomes and the Operation TALL Strategic Objectives as set out by DCC Malcolm Graham. This report discusses the flexible and adaptable response to the challenges posed to COVID-19 by Police Scotland (SO1, SO2 and SO5). It further highlights the activitie undertaken by Police Scotland to protect our people (SO4). The levels of intervention activity discussed in the report serve to protect our communities from COVID-19 (SO SO2). The frequent, transparent publication of papers, such as this, and those publishes on the Police Scotland website provide engagement with communities, to maintain true and confidence (SO3)									

5. Main Report

5.1 SERVICE CENTRE DEMAND

In the last week, the volume of 101 and 999 calls to Police Scotland has remained relatively static. There has been no significant change in demand, but a trend towards certain demands increasing towards more normal levels is continuing.

5.2 INCIDENT DEMAND

When comparing to the previous week, attended public nuisance incidents again saw a decrease of 4%. Attended noise complaints increased by 6%, with incident volumes on the whole remaining static from the previous week. Theft and Assault incident types continue to remain at fairly consistent, low levels when comparing to the previous week, whereas Missing Persons incidents have increased by 10%. However, in comparison to the previous year each of these incident types are all trending significantly lower.

5.3 CRIME

Crime has continued to trend at levels lower than seasonal averages. Recorded crime has remained static from the previous week and down 5% when compared to the same week last year. There has been a decrease of around 9% in the level of Fraud from the previous week, but volume is still significantly higher than last year.

5.4 COVID-19 INTERVENTION ACTIVITY

Police Scotland's use of the COVID-19 legislation continues to be to engage with people, explain the provisions and encourage them to comply with the necessary restrictions, with enforcement action being taken only where absolutely necessary. This has been the overall approach and tone of policing in Scotland since the inception of the public health emergency.

The highest proportion of interventions by police result in individuals dispersing on request. This is in line with Police Scotland's policing approach in respect of this new legislation.

In the last seven days Police Scotland officers attended 18885 incidents. This provides some context to the fact that the new intervention powers have been used on 6,930 occasions, the vast majority non-punitive. Officers have had to resort to enforcement action on 352 occasions throughout the week, with a substantial number occurring on Saturday 9th May.

A substantial amount of work is in progress to prepare for the phases and nature of measures that may be introduced by the Scottish Government in the future to release

lockdown. A relatively minor adjustment to Scottish Government guidance was issued during the reporting period regarding the frequency with which people could exercise, and this has resulted in a re-emphasis of the Police Scotland guidance to officers and staff around policing to the regulations, which have not yet changed, and also a reminder about the style and approach of policing in public space when individuals are likely to be exercising.

5.5 PERSONAL PROTECTIVE EQUIPMENT (PPE)

The procurement and supply of PPE to officers and staff continues as a priority and significant effort is ongoing to ensure our officers and staff are provided with the protection and guidance they require. The Operation TALLA Logistics Cell continues to provide extensive training, equipping and resupply 24 hours a day.

As of 13th May, around 11826 frontline police officers and staff have been trained and supplied the necessary PPE. This is in conjunction with significant measures to introduce physical distancing within the workplace wherever possible. A more detailed report on PPE is being prepared for the Scottish Police Authority.

5.6 OFFICER AND STAFF COVID-19 SCREENING

People & Development continue to support our workforce and to provide reassurance to officers and staff who are symptomatic. To assist with returning them to work as soon as possible, a formal COVID-19 testing regime was introduced. Over the weekly reporting period, 109 officers and staff had tests arranged. This brings the total number of arranged tests, as of 13th May, to 1033. Of these tests, 190 have returned as positive for COVID-19. These figures provided do not include arranged tests and positive tests that have been coordinated locally outwith People & Development process.

Following discussions with Scottish Government Health and Justice colleagues, agreement has also been reached on a process for officers and staff to have access to testing on a risk based approach when asymptomatic, such as following an assault where transmission might have occurred. Further work continues to establish if such testing could be made more available as the Scottish Government Trace, Test, Isolate and Support strategy is implemented.

Police Scotland continues to be engaged in discussions about the opportunities to introduce workplace antibody testing, if a valid test becomes available in Scotland.

5.7 COVID-19 NEAR MISSES

'Near miss' forms in the context of the pandemic situation may be submitted for a variety of reasons i.e. when officers are potentially exposed to COVID-19 whilst not wearing PPE, where PPE malfunctions, or in any other instance an officer feels a risk to themselves in a specific occurrence relating to COVID-19. This can occur due to the reactive nature of policing, as well as being influenced by training levels and supply of PPE. After an initial rise

in the submission of these forms peaking on 7th April, the number has dropped and in the last few weeks has remained mostly static. The drop in submission of forms is likely to be attributed to an increase in numbers of officers trained and equipped.

5.8 CUSTODY

Custody volume refers to the amount of custodies held in Police Scotland custody facilities at a given time. The number of custodies fell on the approach to 'lockdown', reaching their lowest level on 29th March. Since that date custody volumes have steadily increased and are now comparable to business as usual levels.

5.7 SUBMISSION

This report is submitted to the SPA for information and consideration.

Appendix A – COVID-19 Weekly Bulletin contains the information which will be released publically by Police Scotland. This information will continue to be released weekly and will synchronise with the weekly SPA reporting for consistent, single data timelines.



Incident volume this week shows as being relatively similar levels when compared to the same time last year. There has been no significant shift in demand over the last 7 days.




Crime Levels

Total Crime (Year to Date vs Prev. Year to Date)




Staff Absence and Welfare

Staff COVID Screening


Testing of key workers for COVID-19 continues, and the number of tests arranged for Police Scotland employees is broken down later in this report.


Co-operation with new Coronavirus Legislation

The below chart is indicative of the co-operation levels experienced by Police. The majority of interactions between Police and the public are resolved without enforcement.




<u>Total Number of Interactions Relating to Coronavirus Legislation</u>



Cumulative Service Centre Demand (19 March – 13 May 2020)






Weekly Incident Demand (7 May - 13 May 2020)


Cumulative Incident Demand (19 March – 13 May 2020)







Cumulative Crime Demand (9 March – 10 May 2020)














'Enforcement' of Coronavirus specific legislation

The following is a summary of all 'enforcement' action in relation to both The Health Protection (Coronavirus) (Restrictions) (Scotland) Regulations 2020 and Coronavirus Act 2020.


This includes all Fixed Penalty Notices issued and processed by Police Scotland. It also includes all occasions that a charge was libelled and recorded on Police Scotland's Crime Recording System against a person in relation to the aforementioned legislation. This is a true value of the volume of recorded 'enforcement' activity, but does not provide the granularity of the Coronavirus Intervention (CVI) recording system and does not capture the earlier phases of the '4 E's' approach.

These values remain subject to change as offences are retrospectively added or amended and do not match the indicative 'enforcement' values from the CVI recording system.






Weekly Absence (7 – 13 May 2020)



All Absence (18 March – 13 May 2020)


