#### **1. Welcome and introductions**

The Chair welcomed attendees. Apologies were noted as above.

#### 2. Note of the previous meeting and matters arising

The group noted the minute of the meeting held on the 07<sup>th</sup> May 2021.

#### 3. Easing of restrictions - issues arising, including travel.

John Scott provided a high level summary of the weekly data report from Police Scotland updating the group that interventions were down and indoor activity was up.

The group considered an update from IAG Member, Aamer Anwar on his experience of events during the previous day, in Kenmure Street, Pollokshields, in response to the detention of 2 individuals by UK Immigration Enforcement.

ACC Gary Ritchie provided an overview of the involvement of Police Scotland in these events. He thanked Aamer Anwar for his comments and recognised the role played by Mr Anwar in reaching a resolution on the day. ACC Ritchie confirmed that Chief Superintendent Mark Sutherland planned to attend the next meeting of the IAG and would be in a position to provide this group with a more detailed understanding of the strategic decisions taken and the considerations which led to the safe resolution of the incident.

In response to a question about whether the temporary Coronavirus police powers had been considered as part of the approach taken by commanding officers it was confirmed that the pandemic and associated temporary police powers would absolutely have been considered as part of the decision making process and this would be part of the update from CS Sutherland next week.

It was recognised that the Operation Urram Oversight Group may have an interest in considering any learning from events in Pollokshields.

ACC Ritchie updated the group that plans were in place for what was expected to be a very busy weekend for Police Scotland with football celebrations and protests anticipated. The group heard that across all Police Scotland decision making, the matter of public safety would be paramount.

ACC Ritchie further updated attendees that, as the restrictions ease further and more licenced premises opened, the demand was expected to return to nearer pre Covid levels. It was reported that local policing plans were in place and the 4 Es approach would remain in use, however it was recognised that challenges would soon arise as apparently different approaches start to be seen across the country, giving rise to questions about consistency. ACC Ritchie explained that it was important that local commanders were able to decide how best to police their regions.

Recognising that discussions were still underway with regards to the possibility of local lockdowns, the group was assured that Police Scotland were contributing to these discussions at an appropriate level.
