1.	Purpose								
1.1	This paper provides the Scottish Police Authority (SPA) with a weekly update on policing changes seen during Operation TALLA, Police Scotland's COVID-19 response.								
	This report contains the preceding week's information and data on changing demands within the service centre, incident attendance and crime. It will also consider our COVID-19 response including our use of the emergency legislation and how we are assisting our officers and staff welfare throughout these challenging times. This update will have a reporting period of Thursday to Wednesday. For the purpose of this report, the week of Thursday 27th August 2020 to Wednesday 2nd September 202 is considered.

4. Alignment to Police Scotland Strategic Outcomes This report aligns to both Police Scotland's Strategic Outcomes and the Operation To Strategic Objectives as set out by DCC Malcolm Graham. This report discusses the flexible and adaptable response to the challenges pose COVID-19 by Police Scotland (SO1, SO2 and SO5). It further highlights the action undertaken by Police Scotland to protect our people (SO4). The levels of intervent activity discussed in the report serve to protect our communities from COVID-19 (SO2). 5. Main Report

5.1 CURRENT LANDSCAPE

Over the last week, Police Scotland have continued their support of communities throughout the country as we continue to move through 'Phase 3' of the 'Route map through and out of the Crisis' and are now closely monitoring the situation in Greater Glasgow in regards to guidance implemented on 2nd September advising against any mixed household gatherings outwith existing extended family bubbles for single parents or those living alone.

Police Scotland's approach has remained unchanged throughout the pandemic period, promoting 'Engage, Explain and Encourage' prior to 'Enforcement' action being taken.

The "open" status of indoor licensed premises for eating and drinking continue to have no significant impact on frontline policing. Mandatory use of face coverings within retail premises continues to generate calls however the rate of these calls are declining and the incidents are predominantly resolved by use of the first '3E's'.

In a small number of areas across Scotland, small clusters of Coronavirus are emerging. These are subject to tracking and, at this time, are not having a significant impact on frontline policing.

Legislation came into effect on Friday 28th August which gives officers the power to force entry into house parties and take action when the number of attendees exceeds 15. At the time of writing, there have been no instances of the power to force entry having been used.

Scientific data used by the Scottish Government suggests that COVID-19 transmission is significantly driven by gatherings in an indoor setting. The legislation implemented on 28th August, as well as local guidelines instigated in the Greater Glasgow area has been put in place to mitigate the impact of this method of transmission. Indicative figures from the weekend of 28th-30th August suggested that Police Scotland attended over 300 occurrences of house parties throughout the force area. There is a concern that these significant numbers, accompanied by the fact that 6 FPN's were issued and 3 persons arrested may indicate that willingness to follow guidelines limiting persons within private areas may be declining.

From 31st August, gyms and swimming pools reopened and non-contact indoor activity has resumed. This has had no impact on operational policing.

Looking ahead, in the coming weeks further Phase 3 changes have been proposed. On 11th September, the Scottish Government hope to allow non-essential offices and call centres to reopen.

On the 14th September, the Scottish Government hope to allow the following – soft play, live events, indoor entertainment venues to open, indoor sports courts, dance studios, stadia and indoor contact sports.

It is anticipated that these further relaxations of the guidelines will see policing demands continue to revert back to levels comparable with last year. Following local restrictions

having been implemented in both Aberdeen and Glasgow over the last month, it is very possible that, over the coming weeks and months further such restrictions may necessary within other areas across the country. The number of house party incidents attended, despite the restrictions around them, including the large scale planned event in Midlothian consisting of 300 persons (discussed in section 5.10), lead to concerns that the public may be becoming less accommodating of the legislation and guidance. It is recognised that these incidents are only those which have come to attention of the police and that, in reality, the figure is likely to be higher. Increasing behaviours which disregard the public health of Scotland may result in more enforcement activity under both COVID-19 legislation and common law Culpable and Reckless conduct being utilised where it is clear that non-cooperation is a conscious and potentially dangerous act. It is acknowledged that this may appear a more robust approach than has been encouraged across the force throughout the pandemic period however keeping the people of Scotland safe continues to be our overarching priority and our actions must evolve to ensure that the few who choose to place our communities in danger are dealt with appropriately.

5.2 SERVICE CENTRE DEMAND

In the last week, the volume of 101 calls answered decreased by 23% compared to the previous week and the volume of 999 calls decreased by 6%. 101 calls answered are still trending at significantly lower figures than the same time last year, now approximately 35% lower. 999 calls are showing at lower levels, approximately 6% when compared to the same period as last year.

5.3 INCIDENT DEMAND

There has been a 5% decrease in total incident volumes when compared to last week, and there has been a 14% decrease on incident volumes when compared to the same period last year. Public nuisance and disturbance incidents decreased on last week's figures by 10% and 3% respectively. Noise calls have decreased on last week's figures by 7%. Noise and Public Nuisance calls are still slightly higher than last year's figures.

5.4 CRIME

Crime volume continues to remain lower than seasonal average. All crime in the last week is at a lower level than a comparable period last year. All divisions have seen crime volumes at a lower level than the same period last year with the exception of Fife which has seen a small increase. Edinburgh continues to see crimes at a reduced level (over 40%) when compared to a similar period last year. This is assessed to be due to the Fringe Festival not occurring this month.

Cumulatively all divisions are recording less crime for this year when compared with last year. All crime types other than Group 5 are also lower when compared to last year.

5.5 COVID-19 INTERVENTION ACTIVITY

During the last week, the government guidance remained in 'Phase 3' of easing lockdown restrictions. The only exception to this has been the introduction of guidance in the Greater Glasgow area which commenced on the 2nd September. Throughout the last week Police Scotland's approach to the use of COVID-19 legislation continues to be to firstly engage with people, explain the provisions and encourage them to comply with the necessary restrictions with enforcement action being taken only where absolutely necessary.

The overall style and tone of policing the pandemic in Scotland has not changed since the inception of the public health emergency.

In the last seven days, Police Scotland officers attended 17369 incidents.

The COVID-19 intervention powers have been recorded on the CVI system as used on 970 occasions this week. The occasions where these powers have been used tend to relate to a small number of gatherings of large numbers of persons requiring to be moved on.

Since quarantine regulations came into force on travellers entering Scotland from outwith the UK on the 15th June up to and including 30th August, Police Scotland have received 125 referrals from Public Health Scotland (PHS) relating to potential breaches of quarantine, 59 of which were dealt with by the resolution team and 63 of which have been dealt with by local policing and 3 are currently ongoing. In over 70% of such referrals, the travellers were found to be complying with quarantine restrictions. In the majority of the remaining referrals, the travellers have been untraced due to a variety of reasons such as inaccurate data provided to PHS or the expiration of the quarantine period prior to persons being traced.

There continues to have been only one fixed penalty notice issued in relation to a breach of Travel Regulations. This was issued on 11th August and has been mentioned in previous reports.

5.6 PERSONAL PROTECTIVE EQUIPMENT (PPE)

Securing suitable PPE remains an ongoing priority and the dedicated logistics cell has continued to provide extensive training, equipping and resupply, operating on an early shift late shift basis. Supply lines remain fragile and this will be a long term challenge. Up to and including the 30th August, frontline police officers and staff have attended over 21,000 training courses to allow them to wear the most appropriate PPE. This is in conjunction with the provision of significant measures to implement physical distancing within the workplace wherever possible. The dedicated training programme has now been completed, with the vast majority of officers and staff trained.

5.7 ABSENCE

Over the past week, employee absence levels have been at a similar to level to last year. Those absences related to COVID-19 have decreased from last week and are currently sitting at 157.

5.8 OFFICER AND STAFF COVID-19 SCREENING

People & Development continue to support our workforce, providing reassurance to officers and staff who are symptomatic, to assist with returning officers and staff to work as soon as possible. Symptomatic testing arranged up to the 31st August now numbers 1240. The total number of tests organised by Police Scotland sits at over 2100.

From all testing, 207 have returned as positive for COVID-19.

Testing of asymptomatic officers and staff based on risk commenced on 14th May and 343 tests have been arranged up to and including 31st August. None of these tests have yet returned a positive result.

Contact tracing numbers are now being reported and this currently stands at 32, with 3 positive tests.

Police Scotland continues to be engaged in discussions about the opportunities to introduce workplace antibody testing should a valid test become available in Scotland.

5.9 COVID-19 NEAR MISSES

'Near-miss' forms in the context of the pandemic situation may be submitted for a variety of reasons i.e. when officers are potentially exposed to COVID-19 whilst not wearing PPE, where PPE malfunctions, or in any other instance an officer feels a risk to themselves in a specific occurrence relating to COVID-19. This can occur due to the reactive nature of policing, as well as being influenced by training levels and supply of PPE.

The most current 'near miss' figures available date 18-24th August show that 20 forms were submitted. This is the same level of forms submitted the week previous.

5.10 HOUSE GATHERINGS

Scottish Government commissioned data suggests that spread in and between households is driving much of the transmission of COVID-19 at the present time. This analysis has guided decisions to both issue guidance to the Greater Glasgow area advising to cease having indoor gatherings of mixed households outwith established extended family groups containing persons living alone or single parents for the time being and issue new legislation providing police a power of entry into house gatherings and take action when the number of attendees exceeds 15.

Police Scotland have undertaken an assessment of the demand posed by house-gatherings over the weekend of 28-30th August. This is due to the weekend being the most traditionally busy part of the week for such gatherings and legislation being implemented on the 28th August. Information gathered is indicative and should not be considered police statistics. Over the weekend, it was identified that 307 house gatherings were attended by the Police. This has placed a significant demand on police resources. Over the same dates there were 678 interventions recorded on the CVI systems as taking place in a private dwelling or private property. As stated in section 5.1, these occurrences resulted in 6 FPNs being issued and 3 arrests.

Notable incidents from this period include enforcement action taken against the organiser of a large event in Gorebridge, Midlothian in which 300 persons who attended from across the UK were gathered for a pre-planned, paid to enter party in a short-term rented property. At a house party in Kirkintilloch two persons were arrested, 5 FPNs were issued and 20 persons were asked to leave.

5.11 CUSTODY

'Custody volume' refers to the amount of individuals held in Police Scotland custody facilities at a given time. The number of custodies fell on the approach to 'lockdown', reaching their lowest level on 29th March. Since that date, total custody volumes have increased and, in recent weeks have returned to levels comparable to pre-COVID business as usual. The organisation is seeing traditional weekend peaks returning which were less noticeable during the early stages of lockdown.

5.12 SUBMISSION

This report is submitted to the SPA for information and consideration.

Appendix A – COVID-19 Weekly Bulletin contains the information which will be released publically by Police Scotland. This information will continue to be released weekly and will synchronise with the weekly SPA reporting for consistent, single data timelines.





Incident Demand



Crime Volume (9 March – Present compared to Previous Year)



Absences had generally trended lower when compared to 2019. However there has been a recent increase in absences that now have seen levels return to 2019 levels.




Staff COVID Screening







Cumulative Service Centre Demand (19th March – 2nd September 2020)






Weekly Incident Demand (27th August – 2nd September 2020)







Weekly Crime Demand (24th – 30th August 2020)









Cumulative Crime Demand (9th March – 30th August 2020)












'Enforcement' of Coronavirus specific legislation

The following is a summary of all 'enforcement' action in relation to both The Health Protection (Coronavirus) (Restrictions) (Scotland) Regulations 2020 and Coronavirus Act 2020.

This includes all Fixed Penalty Notices issued and processed by Police Scotland. It also includes all occasions that a charge was libelled and recorded on Police Scotland's Crime Recording System against a person in relation to the aforementioned legislation. This is a true value of the volume of recorded 'enforcement' activity, but does not provide the granularity of the Coronavirus Intervention (CVI) recording system and does not capture the earlier phases of the '4 E's' approach.


These values remain subject to change as offences are retrospectively added or amended and do not match the indicative 'enforcement' values from the CVI recording system.






Total Absence (18th March – 2nd September 2020)





Near Miss and Testing Data (w/e 23rd March – 24th August 2020)



'Near miss' forms in the context of the pandemic situation may be submitted for a variety of reasons. i.e. when officers are potentially exposed to: COVID-19 whilst not wearing PPE, where PPE malfunctions, or in any other instance an officer feels a risk to themselves in a specific occurrence relating to COVID-19.


This can occur due to the reactive nature of policing, as well as being influenced by training levels and supply of PPE.

The amount of forms submitted continues to be attributable to the process for requesting an asymptomatic COVID-19 screening test due to an occupational risk, requiring the submission of a 'near miss' form. Many of the reports would not have been submitted without this requirement. The number of incidents where a lack of PPE is identified has not risen.

*Work has been undertaken resulting in some duplication of results being corrected which has resulted in a drop, particularly with regards to self referral reporting data, of positive and some negative cases.

*Please note that individuals who are 'traced' are not always deemed suitable for testing and suitability is determined by the NHS. These tests are not arranged by Police Scotland. For those who have been tested within Phase 3, we have recorded the result accordingly.

*Please note Testing Data is now being reported weekly. The last Testing data report was received on 31st August 2020 and includes tests arranged up to and including 2nd September 2020.
