## Actions from meeting 16th April

- 3) Police Scotland will share a copy of the Gold Strategy for Operation Talla (Police Scotland)
- 4) Scottish Police Authority will share Fortnightly Report on Operation Talla, already shared with the Scottish Police Authority (SPA) this report is still in preparation as of 20th April.

- 9) Copy of EQHRIA on Covid 19 legislation to be sourced and shared with the group (in progress)
