1. Welcome and introductions

The Chair welcomed members to the meeting.

2. Note of previous meeting and matters arising

Matters arising were mainly covered in the agenda.

Professor McVie confirmed that Professor Ben Bradford will attend the IAG meeting on the 9th October.

3. Data Update

The group will meet next Thursday 1st October, in the meantime Professor McVie has been analysing nominal data and will prepare a report for the meeting.

In preparation of the final IAG report to the Board on 25th November Professor McVie intends to prepare a timetable for analysis and presentation of a series of smaller reports, either weekly or fortnightly to the IAG.

Members were asked to consider whether they had any additional data requests. It was clarified that Police Scotland could not provide data on individuals complying with the first 3 E's, as this had not been collected.

Citizenspace

There have been no additional submissions to the Portal. Professor McVie offered to pull together the free form comments submitted in recent months for consideration by the IAG and for inclusion in the final report.

It was agreed that the deadline for submissions through the portal be extended to 31 October. The Chair urged IAG members to share the link to the portal again to encourage further submissions.

4. Scottish Police Authority Board Meeting – 30th September 2020

Prior to the meeting the Chair circulated a draft report to members. He outlined the areas that he had included and those he particularly wished to highlight.

As a result of the current challenges around universities, it was agreed that the Chair would expand the section on Children and Young People with any input thought appropriate from Bruce Adamson, CYPCS. Members discussed the issues that had been at the forefront of the past few days including; what is the legal definition of a household; the impact on the mental health of young people away

from home and now requiring to isolate and concerns that young people may consider dropping out of education.

Members were asked to submit any further comments on the draft report by Monday morning.

It is intended that the report will be submitted to the SPA on Monday afternoon.

The updated work plan and the human rights discussion paper, Article 11 of the ECHR: right to freedom of peaceful assembly, prepared by Diego Quiroz will be included as appendices to the report.

Overall, the conclusion remained that Police Scotland were working positively with communities across Scotland, using judgement, balance and proportionality.
