#### Request

Your request for information dated 29 July 2025 is copied below.

Please provide me with all records, briefings, notes, readouts, agendas, emails, attachments and other correspondence related to Donald Trump's visit to Scotland in July 2025.

#### Response

The Scottish Police Authority has considered your request under the Freedom of Information (Scotland) Act (FOISA).

An Authority representative attended the Operation Roll 2 Strategic Partners Gold Group coordinating the policing response to Donald Trump's visit in July 2025. Most of the correspondence held relates to briefings given at this meeting and then shared within the Authority.

Some information has been redacted from emails where this is out of scope of your request or third-party personal information.<sup>1</sup> This exemption is absolute and does not require application of the public interest test. While you may have a legitimate interest in disclosure of this information, it is our view that those interests are overridden by the interests or fundamental rights and freedoms of the data subjects.

Some information has been redacted from partners summary reports 1, 2 and 4 provided. This is considered exempt as it is information regarding incidents of note over the duration of the visit, some of which are ongoing enquiries and may result in a crime being identified.<sup>2</sup> This exemption

requires application of the public interest test. Please note the Authority does not hold the partners summary report 3.

A letter sent from the Authority to the Scottish Government's Director for Safer Communities is considered exempt as this is information requested by the Scottish Government to inform recovery of the costs incurred from the UK Government.<sup>3</sup> It is recognised that the costs incurred are a matter of public interest, and therefore information on confirmed costs is intended for future publication.<sup>4</sup> These exemptions require application of the public interest test.

#### **Public Interest Test**

The public interest factors in favour of disclosure is that:

• This would adhere to the basic principle of being open and transparent in relation to a high profile event.

The public interest factors in favour of maintaining the exemptions are:

- Discussions on cost recovery are ongoing between the Authority, Police Scotland and the Scottish Government, and the UK Government. We would not wish to prejudice these negotiations by disclosing what were estimated costs at the time.
- The information includes estimated costs for policing the visit. While we accept there is interest in this cost, it would not be in the public interest to disclose information before this is refined and confirmed.
- The Scottish Government intends to proactively publish the costs incurred in relation to the recent visit once they are known. The policing costs will be a significant proportion of the total overall cost. Police Scotland has estimated that it will know the actual policing cost in October 2025.
- Disclosing specific incidents of note would prejudice the efficient and effective conduct of policing. This information details actions taken throughout the duration of this type of operation to anticipate and prevent crime, or to establish the identity of people suspected of being responsible for committing a crime.

Therefore, on balance, our conclusion is that maintaining the exemptions outweigh that of disclosure.

#### **Right to Review**

If you are dissatisfied with the outcome of your request you can ask for a review within 40 working days. You must specify the reason for your dissatisfaction and submit your request by email to <a href="mailto:foi@spa.police.uk">foi@spa.police.uk</a> or by letter to Scottish Police Authority, 1 Pacific Quay, Glasgow, G51 1DZ.

If you remain dissatisfied after review, you can appeal to the Scottish Information Commissioner within six months. You can apply online, by email to <a href="mailto:enquiries@foi.scot">enquiries@foi.scot</a> or by letter to Scottish Information Commissioner, Kinburn Castle, Doubledykes Road, St Andrews, Fife, KY16 9DS.

Should you wish to appeal against the Commissioner's decision, you can appeal to the Court of Session, only if you think the law has not been applied correctly.

"While official confirmation has not yet been made, it is important that we prepare in advance for what would be a significant policing operation."

### Police Scotland to seek Government help with 'considerable' costs of Trump visit

The cost of policing a potential visit by US President Donald Trump will be "considerable", a senior Police Scotland officer has said as the force looks to secure extra funding.

It emerged on Wednesday that the force was in the early stages of planning for a visit at the end of this month, though a final date is yet to be confirmed.

The visit, which would likely see the president visit one or both of his golf clubs in Aberdeenshire and Ayrshire, will require substantial policing resources and likely units to be called in from elsewhere in the UK.

Speaking to the PA news agency on Thursday, Deputy Chief Constable Alan Speirs said Police Scotland will be discussing costs with the Scottish and UK Governments.

"You wouldn't be surprised that the cost of policing such an event would be considerable, and we will work with Government around the provision of costs," he said.

But Police Scotland staffing levels will not drop elsewhere in the country during any visit, the senior officer said.

He added: "We will seek support for the financial costs associated with such an event and I'd be confident that those costs will be met."

Asked if the funding would come from the Scottish Government, Mr Speirs said: "That'll be a conversation we would have with Scottish Government, linking into UK Government, in the coming days and it would be part of our planning for the event."

The last time Mr Trump came to Scotland – in between his two terms as US president – he was met with substantial protests.

Mr Speirs said he was confident Police Scotland would be able to deal with any protests, urging those who would want to demonstrate to "do it in a fair and reasonable way and within the realms of the law".

"We're in the early stages (of planning) and we're unclear just as to what that will be for this event," he said. From: @gov.scot

I understand that the operational planning is well underway in Police Scotland, and that it will continue to evolve over the next couple of weeks. I would be grateful if you could please provide us with the indicative costs for policing the visit, calculated on an additional cost basis, including an indication of any assurance that has been undertaken by the SPA on the numbers provided. As I explained to Chris, colleagues are in discussion with the UK Government on issues associated with the visit, including the costs, and any information you can share with us will help to inform these discussions.

I fully appreciate that the costs will continue to be refined, in line with any changes to the operational planning, and would be grateful if you could keep me informed of any significant changes to the indicative costs which arise over the coming weeks.

As with the costs of policing any event, I understand that the actual costs of policing Operation Roll will not be fully understood until after the event.

I look forward to hearing from you early next week.

#### Scottish Government - Finance Position

<u>(Ogov.scot)</u> SG rep at the Gold Group highlighted her role to members, advising that she is the finance lead and requested all bids for cost recovery are detailed and justified, i.e. the additional spend was directly linked to the Presidents visit. Also Scottish Government is not standing up the Scottish Government Resilience Room (SGoRR) unless circumstances dictate.

Pending amendment or addition from Members here are my notes form the 1200 meeting with DCC Connors and ACC Bond which I observed as comprehensive and positive

Overview

ACC B described the overall approach as protection for POTUS rather than a public order operation and this set the tone for the planning.

BAU out with the POTUS locality is at the forefront of considerations and ACC Middleton has a specific focused role in that regard.

There is a plan to prevent deter and disrupt any unlawful or criminal protests or actions.

PS have built in flexibility to be able to step up to public disorder and public protection if required.

Key risks remain around unknown or rapidly escalating protests. The current relatively benign intelligence picture is being balanced against the possibility that political views are expressed which raise the appetite to protest.

The media reported SPF concerns on workforce agreements are all now in place and the PS position did not change to deliver those agreements – misalignment was temporary and down to timing of SPF media lines.

#### **Member Assurances**

Members explored and were assured by questions seeking clarity on:

BAU mitigations and risks

Communication and escalation channels across Op Roll and BAU at ACC and Div Cdr level.

#### 7 Main Report

#### Overview

On Friday 25th July 2025, Mr Donald Trump, President of the United States (POTUS) is now confirmed to be attending Scotland, visiting his resorts at Trump Turnberry Hotel, South Ayrshire and Menie Resort and Golf Course Aberdeenshire, prior to returning to the United States of America on the evening of Tuesday 29th July 2025.

As a result, a significant and complex policing operation (Operation Roll 2) has been established and a multi-disciplinary command structure implemented to deliver this operational nationally.

Assistant Chief Constable Emma Bond is Gold Commander (supported by Assistant Chief Constable Alan Waddell) and Chief Superintendent is Silver, supported by Chief Superintendent relevant geographical and functional Bronzes appointed.

Official confirmation of the visit from the White House, was only made by the White House Press Secretary, Karoline Leavitt, on the evening of Thursday 17<sup>th</sup> July 2025 who announced that POTUS would be visiting Scotland between Friday 25th July 2025 and Tuesday 29th July 2025

Given the global profile of POTUS and both his and American involvement in significant geopolitical events, the significance and scale of the operation should not be underestimated.

The primary reason for POTUS attending Scotland is assessed to be the opening of his new golf course at Menie Estate, however as planning assumptions have developed it is likely that he will meet a number of key political signatories during his time in Scotland.

The information being received in respect of his itinerary remains assumption based and not yet been confirmed as fact; however it is assessed that POTUS will attend at Turnberry and Menie Estates during his stay in Scotland.

There is ongoing proactive monitoring of information and intelligence in order to ensure the safety of POTUS in Scotland.

There is increased media coverage around the visit, and this has attracted some interest on social media.

The assessment that protests will occur in areas of Scotland, including where POTUS resides and for wider protests across Scotland is assessed as likely.

#### **Communications and Engagement**

Home Office retain the communications lead for the visit of POTUS and Police Scotland Corporate Communications are linked into colleagues in Home Office and Scottish Government on a daily basis.

Deputy Chief Constable Alan Speirs has now undertaken a number of media interviews where he discussed a number of operational matters including Operation Roll 2.

Assistant Chief Constable Emma Bond retains responsibility for media and communications as Gold Commander, with Assistant Chief Constable Alan Waddell managing any talking head requirements during the deployment phase in his role as Gold support. In the event of any extremis situation communications will be led by Deputy Chief Constable Alan Spiers.

Police Scotland have published comprehensive guidance for officers and staff to support them during any Operation Roll 2 deployments.

#### Concurrent Events

The are a number of concurrent events across Scotland during the potential dates for the POTUS visit, including football games in Glasgow and Edinburgh, Climate Camp and a UKIP Mass Deportation Procession.

Planning for Climate Camp and the UKIP Mass Deportation remain under the planning auspices of Operation Roll 2.

The remaining events will be managed via separate command structures and overseen via Business as Usual (BAU) Gold structures under the command of Assistant Chief Constable Wendy Middleton.

#### Resourcing

Police Scotland have been working closely with colleagues in Scottish Police Federation, Association of Police Superintendents and staff Trade Unions to support the welfare of staff and officers throughout Operation Roll 2

Support has been provided by the National Police Coordination Centre (NPOCC) to secure specialist mutual aide officers to enhance the delivery of the operation.

BAU remains a priority with dedicated command structures, ensuring resilience to continue to deliver services across the communities of Scotland. The operations deployment model allows for flex of resources to support BAU if required.

#### **Training**

There has been a proportionate review of training which ensures that priority training in respect of TASER, anti-racism, driver training and probationer modules continue. There is ongoing review of all aspects of training to ensure no impact on business as usual, and work is already ongoing to scope staff for training following the delivery of Operation Roll 2.

#### **Finance**

Discussions remain ongoing with UK and Scottish Governments in respect of funding for the policing of this private visit.

Police Scotland finance colleagues estimate an upper costing of £20 million for the policing of the visit, however with the resourcing of the operation progressing it is anticipated that this figure will be subject of refinement to allow enhanced reporting.

Operation Roll 2 continue to work closely with finance and procurement to ensure best value and a proportionate and necessary expenditure in line with organisational and public expectations.

#### Risk and Health and Safety

The risk assessment and register remain subject of ongoing work with plan owners working closely with Governance, Audit and Assurance colleagues to proactively identify and mitigate risks.

Health and Safety colleagues continue to support the safe delivery of the operation, with induvial and meaningful risk assessments undertaken and reviewed by Health and Safety colleagues.

#### **Partnerships**

Police Scotland continue to work closely with partners across Scotland, the United Kingdom and America and Gold and Silver Groups are now well established.

There have been regular meetings with Scottish Government colleagues, up to and including the First Minister, Mr John Swinney.

The Multi Agency Coordination Centre (MACC) will be established at Command Contact and Control Centre, Helen Street Govan and representatives from agencies and responders will be in attendance 24/7 across the delivery phase of the operation.

#### Testing and Exercising and Organisational Learning and Development

Testing and Exercising supported by SMARTEU has taken place with positive outcomes in terms of the testing of command structures and roles and responsibilities during the deployment phase of the operation.

Debriefings for Operation Roll 2 are scheduled to take place immediately following the conclusion of the operation and the learning and recommendations will be captured and progressed to ensure organisational and learning relevant for future significant and large scale operations.

#### Conclusion

Extensive and complex planning for the visit of POTUS has prioritised proportionate resourcing with cognisance to welfare of staff throughout the planning and deployment phases of the operation.

The command structures for climate camp, public disorder and BAU are closely linked with flexing of resourcing a priority for the command teams to minimise disruption to our communities and maximise the safety of the public and our officers.

This report will form the first in a series of situational updates during the deployment and post operation phases for Operation Roll 2.

As you are aware I have been attending Operation Roll 2 – the Partners Gold Meeting over the weekend, chaired in the am by ACC Emma Bond and in the evening by CS

Also in attendance were representatives from Scottish Government, UK Government, the relevant Local Authorities, SCTS, COPFS, MoD, SAS, SFRS, and the Maritime and Coastguard Agency.

There are no significant threats, issues or incidents linked to President Trumps stay in Turnberry at this time.

#### Incidents of note

25 July -

25 July – 14 Greenpeace activists suspended themselves from the Forth Bridge using climbing equipment with intent of preventing vessels departing or completing their journey to INEOS Grangemouth. 10 persons arrested,

. Although not directly Trump related, the Greenpeace actions closed the Forth Road bridge for almost 14 hours Saturday into Sunday morning, impacting on policing resources and road network locally.

#### Itinerary

28 July - Later today the President, who will be joined this morning at Turnberry by the Prime Minister will move from Turnberry by road, to Prestwick Airport, both will fly on Airforce 1 to Lossiemouth, for onward helicopter flight to Trump International Golf Links, Menie.

#### Issue

The only issue to emerge over the weekend was challenges with Officer transfer travel from the staging posts to deployments. This was a result of a small number of factors, primarily linked to supply by private contractors but did mean that Officers were held beyond scheduled finishing times. The Federation are aware and as of yesterday afternoon this problem was believed to be resolved.

I will be able to confirm the transport issue is resolved when I attend this morning's Gold group at 1100 hours.
