#### **PURPOSE**

To provide members with an overview of progress made by Police Scotland in response to the Recommendations made by HMICS in its Strategic Review of Police Scotland's Response to Online Child Sexual Abuse & Exploitation published in February 2020 and its subsequent progress review, HMICS' Review of Online Child Sexual Abuse, published in August 2021.

Members are invited to discuss the contents of this paper.

### 1. BACKGROUND

1.1 In February 2020 HMICS published its <u>Strategic Review of Police Scotland's Response to Online Child Sexual Abuse & Exploitation</u> (OCSAE). This Review produced 10 recommendations.

Strategic and Tactical Tackling Online Child Sexual Abuse (TOCSA) governance structures within Police Scotland were used to manage and coordinate the response to the recommendations. Significant work was undertaken however it commenced in early 2020, against the backdrop of the Global Pandemic which impacted upon all agencies.

Work towards the recommendations continues and the swift return of HMICS in mid-2021 for its Progress Review ensured focus. The <u>Progress Review</u> was published in August 2021, discharging 3 of the original recommendations, declaring 7 of the recommendations partially met and introduced a further, 11<sup>th</sup> Recommendation.

Further evidence has since been submitted to HMICS in April 2022 and Police Scotland awaits feedback from HMICS as to whether or not a number of the remaining recommendations might be fully discharged.

#### 2. PROGRESS TO DATE

### 2.1 Recommendations Progress

The February 2020 HMICS Strategic Review of Police Scotland's Response to Online Child Sexual Abuse & Exploitation contained 10 recommendations, with an 11<sup>th</sup> recommendation added by the 2021 Progress Review. A detailed progress report against each recommendation is appended to this report. Further evidence submissions were provided to HMICS in April 2022. Significant work has been progressed through the TOCSA structures and a professional assessment by the business area in conjunction with Governance, Audit and Assurance of the evidence submitted was:

- 3 Recommendations (3, 7 & 10) already discharged in 2021
- 4 Recommendations (1, 2, 4 & 9) submitted for consideration of discharge.
- 2 Recommendations (6 & 8) submitted for further direction / or discharge.
- 2 Recommendations (5 & 11) assessed as Work Ongoing.

#### 2.3 Governance

ACC Major Crime, Public Protection & Local Crime retains overall strategic leadership for the work to meet the HMICS recommendations. This has been, and continues to be, managed through the pre-existing Police Scotland TOCSA strategic and tactical structures, meeting quarterly and bi-monthly respectively. TOCSA tactical is chaired by the DCS – Head of Public Protection.

## 2.4 Timescales & Interdependencies

The impact of the pandemic on timescales for progress was not insignificant. Many of the recommendations required collaboration across multiple Police Scotland business areas, as well as ICT work and HR processes where recruitment has been required. These complex and cross cutting interdependencies have at times pushed out timescales for certain recommendations.

## 2.5 Next Steps

Police Scotland continues to progress towards finalising outstanding pieces of work for the undischarged recommendations and also the work to bring to a conclusion and submit further evidence for Recommendations 5 and 11.

Police Scotland awaits feedback from HMICS as to whether Recommendations 1, 2, 4 & 9 might be discharged or further evidence is required.

Police Scotland awaits further direction and clarity from HMICS on Recommendations 6 & 8.

### 3. FINANCIAL IMPLICATIONS

3.1 Whilst there are cost implications associated with the work underway as a consequence of some of the recommendations, finances have been identified and allocated and there remain no identified financial risks connected to the delivery of the recommendations.
