1) Introduction from the Chair and matters arising

Terms of Reference

Operation Talla Short Life Working Group (Optical)

The Chair referenced discussions at the Police Scotland OPTICAL Short Life Working Group, in which he, Martyn Evans and Susan McVie participated.

The Optical group will co-ordinate the demands placed on the service around data and evidence to support accountability and reporting, understanding impact, and forward planning for future transition.

Optical is happy to support the work of the IAG, and there is a request that the IAG provide as much clarity as possible when framing requests for information.

2) Communications Engagement and Reporting

The Chair noted the range of comments received online and via social media. He indicated that members receiving feedback could share any concerns with the group, or seek advice or support if that is required or will assist.

The Chair thanked group members for their suggestions offered to date, including the suggestion to seek assistance from umbrella organisations in reaching out across their networks and to test awareness of differential impacts.

The group discussed the development of public access channels and methods for accepting information from interested groups and members of the community.

It was agreed that an engagement framework would be beneficial to ensure the different levels of communication are complementary rather than cutting across each other.

Alastair Pringle informed the group of a national proposal from EHRC to bring members of key characteristic groups together, and agreed to share more information on this.

The group agreed to undertake further work to identify key questions in evidence gathering and to underpin engagement

3) Priorities for evidence gathering

The discussion was introduced by Professor McVie, and framed around the supporting papers she had provided.

Discussion focused on key questions around three priorities

1. Application of the Powers

2. Acceptability of the powers

3. Compliance

There was a wide ranging discussion on all 3 elements, which will inform a further paper to the group.

Points covered included:

- Scope for partners to utilise their own networks to access information and public perspectives on impacts and to help the group understand disaggregated impact more fully
- Requirement for the group to quickly shape and clarify its key questions
- The increasing challenge for policing as we emerge from lock down, with potential for less use of engagement and an increase in enforcement
- The scope for partners and IAG members to offer advice to assist effective transition
- Strengthening clarity and alignment of communication on legal position and public health advice
- The need for regular data updates to be provided by policing
- The benefits of contextual framework in understanding the data
