Professor McVie briefed members that she had been invited to speak to the Justice Board.

She indicated that Joe Griffin, Scottish Government Director of Safer Communities, is now leading SG work on public compliance. Members agreed to invite Mr Griffin to a future IAG meeting.

Optical Update

Professor McVie introduced and discussed her briefing paper with members.

The work to check and match data across Police Scotland and SCTS data sets continues, and some additional manual checking may be required to understand any discrepancies across the two data sets.

There is no significant difference in the proportion of Covid and Non Covid FPN's which have been paid. A greater proportion of Covid related FPNs have been discharged, however, with most of these being re-registered for payment in some other way.

A very small number of Covid related FPNs have been challenged. Police Scotland will consider and report into Optical on Covid related tickets which have been challenged.

There are no significant differences in numbers of Non Covid FPNs issued during Q1 of 2019/20 and 2020/21.

Members discussed the potential for any additional data to be made available to support better understanding of police engagement during the pandemic under

the new powers, for example information on arrests, reckless behaviour charges, or quarantine enforcement.

Work is ongoing on nominal data, for future report to the IAG.

Quarantine and Gatherings

DCC Will Kerr updated members on Covid 19 policing activity. Police Scotland will publish this data weekly, and the IAG will be notified ahead of time.

In the week up to Sunday 11th October, there were 2 instances of forced entry to premises relating to Covid 19 breaches.

Officers attended 361 reports of breaches of Covid regulations relating to house parties and gatherings, of which 31 related to students. 258 were found to be in breach of regulations.

DCC Kerr indicated that although the Covid19 situation has become more complex, Police Scotland remain consistent with the 4E's approach, and that effective communication and scope for discretion has become increasingly important.

Members discussed a range of issues related to changes in regulations and any additional restrictions.

Regulatory travel restrictions in Wales were noted. Members indicated some concern about the impact of additional road traffic restrictions, noting the experience in Melbourne of disruption and access issue, for example, for emergency services.

There is evidence that an increasing number of people favour additional restrictions and stronger enforcement, which may not align with their own behaviour or the known factors which support adherence and compliance. This issue will be referenced by the Chair in the November report to the SPA Board

The Chair highlighted the importance of the "enforceability" of legislation, in supporting public confidence in the system as a whole.
